NOTICE OF ARGUMENT FILING DEADLINES  
Newman-Crows Landing Unified School District  
Measure S and Measure T**

NOTICE IS HEREBY GIVEN to the qualified electors of the **Newman-Crows Landing Unified School District** (the "District") located in the County of Stanislaus, State of California, that in accordance with applicable law, an election will be held on Tuesday, November 5, 2024, within the District, at which election there will be submitted to the voters TWO questions of whether general obligation bonds shall be issued and sold for the purposes specified in the Bond Project List for each measure.

Said measures will be referred to as "Measure S" and "Measure T." The full text of the proposed measures is available at the Stanislaus County Elections Division, 1021 "I" Street, Suite 101, Modesto, California (209-525-5201). The measures will become effective only if approved by 55% of those voters voting on the measures. The electors in the District shall vote on the following measures:

**"Measure S"**

**"Classroom Improvement Bond.** With funds that cannot be taken by the State, shall Newman-Crows Landing Unified School District's measure expanding vocational and career training, special education, and counseling classrooms/ facilities at Bonita Elementary, Hunt Elementary, Hurd Barrington Elementary, Von Renner Elementary, Foothill Community Day, Yolo Jr. High, Orestimba High, and West Side Valley High be adopted, authorizing \$30 million of bonds with legal rates, average levies below \$45 per \$100,000 assessed valuation (raising \$1.7 million annually) while bonds are outstanding, audits, citizen oversight, State matching funds eligibility and full public disclosure of spending?"

**"Measure T"**

**"School Repair Bond.** With funds that cannot be taken by the State, shall Newman-Crows Landing Unified School District's measure to repair or replace leaky roofs, deteriorating classrooms and PE facilities at Bonita Elementary, Hunt Elementary, Hurd Barrington Elementary, Von Renner Elementary, Foothill Community Day, Yolo Jr. High, Orestimba High and West Side Valley High be adopted, authorizing \$27 million of bonds with legal rates, average levies below \$43 per \$100,000 assessed valuation (raising \$1.5 million annually) while bonds are outstanding, audits, citizen oversight, State matching funds eligibility and full public disclosure of spending?"

**ARGUMENTS** must be submitted in person to the county elections official at the office thereof at 1021 "I" Street, Suite 101, Modesto, California, and may be filed by any member(s) of the board or legislative body, any registered voter or a bona fide association of citizens entitled to vote on the measures. Arguments must accompany the signature statement form signed by not more than 5 signers as required by Elections Code 9600. Only one argument for and one argument against will be selected and printed in the County Voter Information Guide. Filing deadlines are determined by the county elections official under the authority of Elections Code 9163, 9286, 9316 and 9502.

**ARGUMENTS FOR OR AGAINST** these measures shall not exceed 300 words and must be filed no later than 5:00 p.m., Monday, July 29, 2024.

**REBUTTAL ARGUMENTS** shall not exceed 250 words and must be filed no later than 5:00 p.m. on Thursday, August 8, 2024.

**NOTICE IS FURTHER GIVEN** that pursuant to current California election laws, all actively registered voters shall receive a vote by mail ballot. Vote centers will begin opening 10 days prior to Election Day to provide in person voting services. Language and accessibility assistance will be available at all voting locations. Secure ballot drop boxes will be available 29 days prior to Election Day. Vote center and secure ballot box locations, dates and times will be listed in the County Voter Information Guide and posted on [www.stanvote.gov](http://www.stanvote.gov). All vote centers and the county elections office will be open 7:00 a.m. to 8:00 p.m. on Election Day, Tuesday, November 5, 2024.

**NOTICE IS FURTHER GIVEN** that ballots from the November 5, 2024, General Election are to be tallied and the canvass of the vote will be conducted at the Stanislaus County Registrar of Voters Office (central counting place) at 1021 "I" Street, Suite 101, Modesto, California, commencing no later than 9:00 a.m. November 7, 2024. Canvass procedures are open to the public. For further information call the county elections official at 209-525-5201.
